KEYNOTE: Journey to the Supreme Court

A conversation between Supreme Court Justice Sonia Sotomayor and Judge David Tatel, U.S. Court of Appeals for the D.C. Circuit.

Join us for a fascinating conversation with Supreme Court Justice Sonia Sotomayor as she shares her public service experiences leading up to her becoming the 111th justice and first Hispanic and third woman to serve on the Supreme Court of the United States. The conversation will be led by Judge David Tatel of the U.S. Court of Appeals for the D.C. Circuit.

Justice Sotomayor graduated from Princeton University and earned a J.D. from Yale Law School where she served as an editor of the Yale Law Journal. She served as Assistant District Attorney in

the New York County District Attorney's Office from 1979–1984. She then litigated international commercial matters in New York City at Pavia & Harcourt, where she served as an associate and then partner. In 1991, President George H.W. Bush nominated her to the U.S. District Court, Southern District of New York, and she served in that role from 1992–1998. She served as a judge on the United States Court of Appeals for the Second Circuit from 1998–2009. President Barack Obama nominated her as an Associate Justice of the Supreme Court on May 26, 2009, and she assumed this role August 8, 2009.

Judge David Tatel graduated from the University of Michigan and the University of Chicago Law School. He began his career at Sidley and Austin before becoming the founding director of the Chicago Lawyers Committee for Civil Rights Under Law. From 1974 to 1977 he served as Director of the National Lawyer's Committee for Civil rights Under Law, and then became the Director of the Office for Civil Rights of the United States Department of Health, Education, and Welfare during the Carter Administration. In 1979, he joined Hogan & Hartston where he founded and headed the firm's education practice until his appointment to the D.C. Circuit in October 1994.


GREEN CONFERENCE




